Mark Merrifield

Director, Center for Climate Change Impacts and Adaptation



Mark Merrifield has spent the past two decades studying global and regional sea-level change. A Scripps alumnus, Merrifield returned to campus from a 20-year stint as director of the University of Hawaii Sea Level Center to direct the Center for Climate Change Impacts and Adaptation. Merrifield's research areas include sea-level rise and climate variability, coastal oceanography, and nearshore processes.

He received his PhD in Oceanography from Scripps in 1989, was a postdoctoral researcher at the University of New South Wales in Sydney, Australia from 1989 to 1991, followed by a return to Scripps as a project scientist and researcher. In 1994, he joined the faculty at the University of Hawaii at Manoa in the Ocean Engineering department, subsequently moving to the Oceanography department from 1997-2017. He has a longstanding interest in linking basic and applied research outcomes to practical solutions for societal benefit.

Merrifield has had experience working with partners in academia, industry, government, and non-government organizations as the chair of the Global Sea Level Observing System, as the lead investigator of the Waves and Water Level component of the Pacific Integrated Ocean Observing System (PacIOOS), and as a lead author of the Sea Level Change chapter of the Fifth Assessment Report of the Intergovernmental Panel on Climate Change. As the new CCCIA director, Merrifield will pursue research that advances the understanding of climate impacts and provides meaningful projections, and develop a focused curriculum that prepares the next generation of scientists, engineers, and policymakers in risk assessment and adaptation strategies.

Ryan has spent a majority of his career in service to the citizens of Oceanside. Councilmember Keim was a Lifeguard at City of Oceanside pools during college, and graduated from California State University San Marcos with a Bachelor of Arts in Political Science.

In 2004, Ryan served on the Police and Fire Commission until he joined the Oceanside Police Department in 2006. While with the Oceanside Police Department (OPD), Ryan worked in numerous assignments including the Neighborhood Policing Team and the Gang Suppression Unit. As a member of the Neighborhood Policing Team, Ryan partnered with various community groups throughout the city to address quality of life issues that often required creative and time-intensive solutions. Additionally, Ryan had the opportunity to work with students in vulnerable neighborhoods to prioritize education and healthy extra-curricular activities. After suffering an on-duty injury, Ryan retired medically as a sworn officer and became the Public Information Officer for the Oceanside Police Department. Ryan then had the opportunity to join San Diego County Sheriff's Department as the Public Affairs Director and primary spokesperson. As a member of the Sheriff's Executive Management Team, he oversaw the Department of Media Relations at one of the largest sheriff's departments in the country.

Serge Dedina was elected Mayor of Imperial Beach in November 2014. A first-generation American, he moved to IB in 1971 at the age of seven and grew up on the southeast side of town near the entrance to Ream Field. Serge attended Berry and Harbor View Elementary Schools, Mar Vista Junior High and Mar Vista High School (Class of 1982). He put himself through UCSD while working as a City of Imperial Beach and Silver Strand State Beach Lifequard where he rescued more than 500 swimmers.

While growing up in Imperial Beach, Serge helped conserve the coastline and open space that make Imperial Beach one of the most beautiful beach cities in California. As a member of the Imperial Beach Youth Commission and Tidelands Advisory Committee, Serge worked with residents, the business community and government agencies to improve the quality of life for residents of Imperial Beach.

The Executive Director and co-founder of WILDCOAST, an award winning non-profit organization for both its programs and high standards of financial and administrative management, Serge helped secure tens of millions of dollars to build a new sewage treatment plant along the U.S.-Mexico border, saving taxpayers more than \$100 million in the process. He received the California Coastal Commission's "Coastal Hero" Award and the San Diego Zoological Society's Conservation Medal in recognition of his conservation efforts. He is a member of the Sweetwater Unified School District's Hall of Fame, received an honorary degree from Southwestern Community College, and was honored as a John Muir Fellow at UCSD.

Serge has a Ph.D. in Geography from the University of Texas at Austin, a M.S. in Geography from the University of Wisconsin-Madison and a B.A. in Political Science from UCSD. In 2013 he received a scholarship from the Harvard Business School Club of San Diego to attend the Harvard Business School's Executive Education Program. A first generation American, Serge has been married to his wife Emily since 1989.

As a father of two boys, Serge has worked to make Imperial Beach a more family-friendly community. He was involved in the effort to build a free community skatepark and provided scholarships for children to attend Junior Lifeguard programs. As a member of the Mar Vista High Poseidon Advisory Board, Serge has mentored MVHS students and provided them with internship and volunteer opportunities. He was a member of the Sheriff's Community Advisory Group, co-founded the Imperial Beach Collaborative and was a member of the SDG&E Community Advisory Board.
